## Minutes of the Fee Regulatory Committee held on 17th March 2017 at 3.30 PM under the chairmanship of Justice S.N. Bhargava

A meeting of the Fee Regulatory Committee constituted under the Chairmanship of Justice S.N. Bhargava by Government of Rajasthan to comply with the orders of Hon'ble Rajasthan High court Jaipur as per judgment dated 14.08.2013 of Hon'ble Supreme Court in the Islamic Academy of Education v/s State of Kanataka and others was held on 17th March 2017 for the determination of fee to be charged by the private institutions for BDS and MDS courses.

Discussion were held regarding existing fee structure and need for revision in view of representation received from private institutions keeping in mind

the investment, recurring expenditure including salary, operations maintenance of infrastructure etc.

After detailed discussions on operational cost for running these colleges excluding capital cost, fee structure of similar medical/dental colleges in state and also taking view of making some provision for self-sustainability of these colleges in future. it was decided that the final fee may be decided by the State Government to a extent not exceeding the recurring cost per student so that the institutions runs smoothly and exhibits sustainable viability. It was decided that the college can charge a fee not higher than amount Inclusive all charges and no hidden charges will be borne by the students except hostel, accommodation conveyance, mess, examination fee etc.

It was decided that total fee to be charged per student per year for the BDS courses may be fixed at **Rs.2.75 lac** and for MDS (Non-Clinical) as **Rs.5.50 Lac and Rs. 6.50** Lac for MDS (Clinical). This fee will be applicable for students getting admissions from academic session 2017-18 for a minimum period of three years.
